## COMPLAINT PROCESS

There are three key steps when dealing with complaints, including:

1. **Acknowledgement:** Once Fortnum receives the complaint, you will receive acknowledgement within 24 hours of receiving it.

2. **Assessment and Investigation:** Fortnum will investigate and assess the complaint after gathering all the required information. This may involve speaking to you directly or to other relevant parties involved in order to gain a suitable resolution.
3. **Providing an Internal Dispute Resolution (IDR) Response:** Fortnum will provide you with written communication to inform you of the final complaint outcome.

## RESPONSE TIMEFRAMES

Fortnum will investigate your complaint and respond to your concerns as quickly as possible and within 30 days. At times, due to the complexity of the complaint and availability of information, it may take longer to resolve. Where a delay occurs, we will contact you in writing and provide you with the reasons for the delay.

## AUSTRALIAN FINANCIAL COMPLAINTS AUTHORITY (AFCA)

If you do not agree to the reason for the delay or if you feel your complaint has not been resolved to your satisfaction, you may refer your concerns to the Australian Financial Complaints Authority (AFCA), which provides an accessible, fair and independent dispute resolution service.
